THE RULE OF LAW AND ELECTORAL INTEGRITY: THE FOUNTAIN OF DEMOCRACY, LEGITIMACY OF GOVERNMENT, PEACE AND SECURITY IN NIGERIA.

Thus, on this footing, I am inviting you all my comrades to rise up to the task of entrenching absolute adherence to the principles of rule of law by our leaders, a hygiene electoral regime whereby the wishes and aspiration of the people will alveays override.

I submit finally that the task of having a better, developed Nigeria though a daunting one but with the conviction I have, I know that we all at the end of this gathering will leave here with the resolve to make it work. Growth and development can only thrive in an atmosphere of peace. I urge every good spirited youth to rise up and be a part of the movement for a new, peaceful, secured and developed Nigeria.
